

RESOLUTION NO. 2015-1

RESOLUTION OF THE SOUTHEAST FLORIDA TRANSPORTATION COUNCIL (SEFTC) REQUESTING THAT THE FLORIDA DEPARTMENT OF TRANSPORTATION (FDOT) CONSIDER REVISIONS TO THE STRATEGIC INTERMODAL SYSTEM (SIS) CRITERIA WHICH RECOGNIZES THE IMPORTANCE OF INTRA-REGIONAL MOBILITY AND INCLUSION OF REGIONALLY ADOPTED PLANS FOR SOUTHEAST FLORIDA, TO THE MAXIMUM EXTENT POSSIBLE

WHEREAS, the SEFTC was created in 2006 through an Interlocal Agreement among the Broward, Miami-Dade and Palm Beach Metropolitan Planning Organizations (MPO) to strengthen regional transportation planning coordination and to prepare a Regional Transportation Plan; and

WHEREAS, the SEFTC has adopted a regionally significant corridor network, as part of the 2040 Regional Transportation Plan for Southeast Florida, which recognizes the importance of SIS facilities and corridors; and

WHEREAS, the Florida Department of Transportation (FDOT) is formally requesting input for the Florida Transportation Plan (FTP) and Strategic Intermodal System (SIS) Plan updates; and

WHEREAS, it is essential that the State prepares policies and plans in a collaborative fashion, that is consistent and compatible with the different regions of the State, including the highly urbanized and multi-modal nature of the Southeast Florida region; and

WHEREAS, it is essential to ensure the State policies and plans allow for funding to be in alignment with the goals and objectives of the Southeast Florida region and its investment decisions.

NOW, THEREFORE, BE IT RESOLVED BY THE SOUTHEAST FLORIDA TRANSPORTATION COUNCIL:

SECTION 1. The SEFTC requests that the FDOT consider revisions to the SIS criteria that recognizes the importance of intra-regional mobility and inclusion of regionally adopted plans for Southeast Florida, to the maximum extent possible.

The foregoing Resolution was offered by Commissioner Bruno A. Barreiro who moved its adoption. The motion was seconded by Council Member Bryan Caletka, and upon being put to a vote, the vote was as follows:
